

Summer 2020 COVID-19 Cancellation and Deferral

Due to Covid-19 we have suspended all pre-determined fee payment deadlines. Any deposits paid will hold spots until we have determined the status of our 2020 summer dance programs. Any fees paid will be refunded until such time as we set-up new date deadlines for the 2020 summer dance season. More details below.

Should students wish to withdraw from the 2020 Summer Intensive program, a full refund of fees paid will be given within two weeks of the request. Should you wish to defer your spot in the program, please let us know and your fees and position will be transferred to the 2021 Summer Intensive Program. In 2021, students will be responsible for paying the remaining amount owing (including program fee increases) by the 2021 deadlines or withdrawing from the program ahead of refund deadlines (see Summer Intensive Refund Policy).

In the event of a cancellation of the program or major programming change by Canada's Ballet Jörgen, we will issue a full refund of fees paid within two weeks of notification.

Throughout the process, and if you are able, we hope that you will consider converting any portion of your refunds into a tax-deductible donation to Canada's Ballet Jörgen to help ensure that we can continue to make our education opportunities available for dancers.

CBJ Summer Intensive Refund Policy

Deposit of \$125.00 +HST (Sum I-III)

Deposit of \$565.00 +HST (Sum IV & JC)

The deposit holds your spot in the program and in residence (if applicable) until full fees are due. Full tuition fees are due approximately 4 weeks before the program start date – specific dates are outlined for each program each season. Full residence and meal program fees have their own schedule, please refer to those specific dates and refund policies in the residence information package. Full fee payments must be made by these specific dates in order to keep your spot in the program and residence secure.

The deposit is fully **non-refundable** as of the following date:

Summer Intensive I, IV, & JC – May 21st

Summer Intensive II & III – July 1st

The deposit is **partially refundable** (amount paid minus a \$65.00 inc. HST administration fee) until the following date:

Summer Intensive I, IV, & JC – May 20th

Summer Intensive II & III – June 30th

The deposit is fully **refundable** until the following date:

Summer Intensive I, IV, & JC – March 31st

Summer Intensive II & III – May 15th

A unique partial refund may be given after the refund deadline in the event of extenuating circumstances such as injury, illness or family circumstance. The reimbursement amount, if any, will be determined at the discretion of the Education Manager and some documentation may be requested. If the program has already started, and a refund is awarded the amount will be pro-rated for the time spent in the program.

Deferring your unused fees to a future summer program is always an option. Please inquire for details.
